NILE Health, Brand & Import Regulations

The NILE is committed to protecting the health of your livestock. Although we cannot guarantee the health of any animals participating in NILE, we have taken steps to minimize the threat of exposure to contagious diseases. The Certificate of Veterinary Inspection issued by your local accredited veterinarian is an important part of our animal health monitoring system at the NILE. A Certificate of Veterinary Inspection is needed even if you live within Montana.

Veterinary services will monitor the health of the animals on the grounds, be available (on private fee basis) should you need assistance with an animal's health or injury problem, and to write outgoing inspection certificates for sale animals. Common items which sometimes get overlooked:

- Failure to get an incoming veterinary inspection.
- · Lack of brucellosis vaccination for female cattle.
- Incomplete documentation by the veterinarian on the inspection certificate.
- · Lack of EIA (Coggins) test on sale horses.

NILE GENERAL REQUIREMENTS:

- 1. All animals presented for exhibition or sale from out-of-state shall be accompanied by a certificate of veterinary inspection and brand inspection. Animals originating from a state that does not have official brand inspections may obtain one upon arrival in Montana. Import permits should be obtained by the accredited veterinarian issuing the Certificate of Veterinarian Inspection within 10 days prior to arrival into Montana.
- 2. Animals presented for exhibition or sale on NILE grounds shall be accompanied by a Certificate of Veterinary Inspection.
- 3. All arriving animals are subject to a clinical inspection. Any animals showing clinical evidence of disease will be refused entry or required to be handled in accordance with directives of the veterinarian in charge. Animals affected with warts, ringworm, pink eye, other skin conditions, unsightly blemishes or any communicable disease will be refused entry into the NILE or removed from the grounds at the discretion of the official show veterinarian and show officials.
- 4. Animals, which develop a disease condition during the course of the show, are to be handled in accordance with the directive of attending
- 5. Exhibitors arriving with sale & show animals should have two health certificates & two brand inspections - sale animals and show animals.

STATE OF MONTANA IMPORT REQUIREMENTS: **BEEF CATTLE:**

- 1. Health Certificate issued within 30 days prior to entry into Montana.
- 2. Permit Number (for hand-written paper health certificates ONLY electronic health certificates do not require a permit number).
 - a. Veterinarians should call 406-444-2976 or email livpermits@mt.gov to obtain a permit number.
- 3. Official Identification
 - a. Animals tagged prior to November 5, 2024:
 - 1. USDA Silver Metal Clip, Bangs Tag, or 840-RFID tags are accepted.
 - b. Animals tagged after November 5, 2024:
 - 1. 840-RFID tags are required.
 - c. Official ID must be listed on health certificate.
 - d. All animals require Official ID, regardless of sex.
- 4. Trichomoniasis Testing for Bulls
 - a. Virgin bulls age 24 months or younger: No Testing is required.
 - b. Non-Virgin Bulls & All Bulls 24 months of age and older: Trich test is required within 60-days prior to entry.
- 5. Statement required for exhibition of bulls:
 - a. "While in Montana, this (these) bull(s) cannot be sold, loaned, leased, and cannot be used for breeding or semen collection, and must be kept separate from all sexually in-tact female cattle"
- 5. M-Statement on Health Certificate
 - a. Required Statement: "The animals in this shipment are NOT M-Branded nor have they been in contact with or exposed to M-Branded Cattle".
 - b. If Cattle ARE M-Branded: Required Statement: "The animals in this shipment ARE M-Branded or have been in contact with or exposed to M-Branded Cattle".

CANADIAN ORIGIN CATTLE:

- 1. International Health Certificate
- 2. Permit number. Canadian cattle import permits cannot be issued over the phone. Please send health certificate and testing documents email or fax, to obtain an import permit. Email: livpermits@mt.gov | Fax: 406-444-1929

- 3. Lactating Cows: Prior to export back to CANADA, lactating beef & dairy cattle are required to receive a negative test for Influenza A. The negative testing of milk or mammory samples via PCR must be docuimented on the health certificate.
- 4. Official ID
 - a. All Canadian origin cattle require an offcial ID listed on certificate.
 - b. All Canadian origin cattle require a CAN Ear Tattoo or CAN Hot
- 5. Brucellosis
 - a. One negative brucellosis test on sexually in-tact animals 12 months of age and older, within 30 days of movement.
- 6. Tuberculosis
 - a. One negative TB test on sexually in-tact animals two months of age and older, within 60 days of movement.
- 7. Trichomoniasis Testing for Bulls
 - a. Virgin bulls less than 24 months of age: No testing required * Required Statement: "The bull(s) identified on this certificate are virgin bulls"
 - b. Non-Virgin Bulls & All Bulls 24 months of age and older: Trich test is required within 60-days prior to entry.

SHEEP:

- 1. Health Certificate issued within 10 days prior to entry into Montana.
- 2. Permit Number (for hand-written paper health certificates ONLY electronic health certificates do not require a permit number).
 - a. Veterinarians should call 406-444-2976 or email livpermits@mt.gov to obtain a permit number.
- 3. Official Identification
 - a. All show/exhibition sheep require official identification.
 - b. ID Options: Official USDA ear tag, breed registration tattoo, scrapie premises ID tag, or premises tattoo.
- 4. Testing: No Testing is required.
 - a. Required Statement: "While in Montana, these sheep will be used for exhibition only and cannot be sold or used for breeding."
- 5. Scrapie:
 - a. Required Statement: "The animals in this shipment were not exhibiting clinical signs associated with scrapie at the time of the examination.
- *** Prohibited Species of Sheep in Montana: (Including but not limited to) Required Statement: "The bull(s) identified on this certificate are Mouflon, Mouflon cross, Barbary, Tahr, Chamois, Aoudad, Barbados, Hawaiian, and Black Hawaiian. ***

MEAT GOATS:

- 1. Health Certificate issued within 10 days prior to entry into Montana.
- 2. Permit Number (for hand-written paper health certificates ONLY electronic health certificates do not require a permit number).
 - a. Veterinarians should call 406-444-2976 or email livpermits@mt.gov to obtain a permit number.
- 3. Official Identification
 - a. All show/exhibition goats require official identification.
 - b. ID Options: Official USDA ear tag, breed registration tattoo, scrapie premises ID tag, or premises tattoo.
- 4. Testing: No Testing is required.
 - a. Required Statement: "While in Montana, these goats will be used for exhibition only and cannot be sold or used for breeding."
- 5. Scrapie:
 - a. Required Statement: "The animals in this shipment were not exhibiting clinical signs associated with scrapie at the time of the examination." 2025Health Brand Regs.pdf

SWINE:

- 1. Health Certificate issued within **10 days** prior to entry into Montana.
 - Due to the report of SVV (Seneca Virus A), ALL hogs will be checked for leisons by a veterinarian prior to being unloaded.
- 2. Permit Number (for hand-written paper health certificates ONLY electronic health certificates do not require a permit number).
 - a. Veterinarians should call 406-444-2976 or email livpermits@mt.gov to obtain a permit number.
- 3. Official Identification
 - a. All swine require official identification.
 - i. Ear tag, tattoo, ear notch, or most other permanent identification
 - b. Per USDA-APHIS regulations microchips are NOT accepted for swine.
- 4. Required Statements on Health Certificate
 - a. "These swine are not PRV vaccinated and have not been fed raw garbage."
 - b. "There has been no evidence of PRV in the herd of origin in the last 12 months."
- *** Prohibited Species of Swine in Montana: All wild species including European boar, Russian boar, and all hybrids thereof either species are prohibited.***

EQUINE:

- 1. Health Certificate issued within 30 days prior to entry into Montana.
- 2. Permit Number (for hand-written paper health certificates ONLY -electronic health certificates do not require a permit number).
 - a. Veterinarians should call 406-444-2976 (24/7 line) to obtain a permit number
- 3. Equine Infectious Anemia (EIA) (Coggins)
 - a. One negative EIA test on all classes of equine within a 12 months prior to entry.

FREQUENTLY ASKED QUESTIONS:

- Q: How long are import permits good for on a hand-written paper health certificate?
 - A: The life of the health certificate, 30 days from the date of inspection of the animals.
- Q: If my Veterinarian issues my health certificate electronically, but prints out a copy for me, does that mean I need a permit number?
 - A: NO. The health certificate was still issued electronically, therefore, no permit number is required.

MONTANA BRAND REQUIREMENTS:

The Guiding Principle of the Brands Enforcement Division is to protect the livestock industry from theft and predatory animals. The Brands Enforcement Division Goal is to provide the livestock industry with professional law enforcement and investigative work in the tracking of livestock ownership and in the deterrence and/or resolution of related criminal activities.

BRAND INSPECTIONS FOR CATTLE AND EQUINES

A Montana Livestock Brand Inspection for cattle and horses is required before:

- a. Crossing a county line or before leaving the state.
- b. Change of ownership.
- The seller is responsible for the inspection.
- c. Sale at a licensed livestock auction.
- d. Slaughter at a licensed facility.

Inspections must be done in daylight.

Inspections are only issued when ownership can be proven:

 A bill of sale signed by the seller and adequately describing the livestock

b. An inspection in the current owner's name.

BRAND INSPECTION FEES:

Cattle Inspections\$1.00
Annual Equine Inspections\$10.00

Allows movement within the state of Montana for 12 months

Lifetime Equine Inspections \$30.00

Allows travel anywhere in the U.S. or Canada.

Must also meet DOL Animal Health and other import requirements.

DRUG USE (as adapted from the National Code of Show Ring Ethics) Legal or illegal substances used to physically alter the appearance, behavior, and/or performance of an animal entered in livestock events are prohibited. Performance enhancing drugs (including, but not limited to; steroids, diuretics, anti-inflammatories, tranquilizers and pain killers) may not be administered 5 days prior to showing the animal.

VIOLATION OF DRUG USE & WITHDRAWL TIMES:

Use of illegal drugs is considered a pre-meditated act! Any information obtained on the practice of illegal alteration of an animal will be turned over to the proper authorities for criminal prosecution.

The use of animal drugs or other substances in any manner other than in accordance with the labeling approved by the Food & Drug Administration (FDA), the United States Department of Agriculture (USDA), and/or the Environmental Protection Agency (EPA) is a violation of federal law. Any animal that exceeds acceptable levels established by the appropriate regulatory agencies, such as the USDA, FDA, and EPA, will be in violation of these rules and appropriate action will be taken. For all drugs or medications given to market animals, the recommended and/or established withdrawal times for that drug must be strictly followed.

Violation of the Drug Use Rule will result in the disqualification of the animal being shown and may result in disqualification of the exhibitor. Disqualification of an exhibitor is a "ONE STRIKE AND YOU ARE OUT POLICY!" Violations of the Drug Use Rule may also result in an exhibitor forfeiting any premium, awards, or auction proceeds and being prohibited from further competition at the NILE Stock Show, as well as being subject to criminal prosecution if proven guilty. A second offense in the same immediate family may result in the barring of the entire family of the exhibitor from further participation in any state supported livestock show.
