### **RULES:**

1. Each animal must be identified by an ear tag or tattoo, which must be listed on the entry form
2. Steers will be classified by hip height; Heifers by age.
3. Steers must be born on or after 1/1/2025. Heifers must be born on or after 9/1/2024 and have not calved.
4. The show coordinators will determine the number per class and the number in the champion drive.
5. Exhibitors must be an active 4-H or FFA member or an active member of a junior breed association of the animal being shown.
6. Showmanship age classification: exhibitor age as of 1/1/2026
  - a. Pee Wee: 6-7 | Beginner: 8-10 | Junior: 11-14 | Senior: 15-21
7. Each exhibitor is responsible for any loss, injury, or damage that may result to exhibitor, exhibitor officers, agents, employees, equipment or animals.
8. Animals eligible for the NILE Club Calf Steer & Heifer Futurities are animals that were purchased and **NOMINATED** at the NILE Club Calf Sale on October 14, 2025. Entries will be verified.
9. Only 2026 NILE Merit Heifers are eligible for the NILE Merit Heifer class.
10. Exhibitors winning more than \$600 will be required to complete a W9 before premiums will be paid out.
11. Please, NO straw or shavings to be used as bedding inside the arena
12. Do NOT dump water buckets inside the facility!
13. The show coordinators reserve the right to interpret the rules as they see fit. Their decision is final.

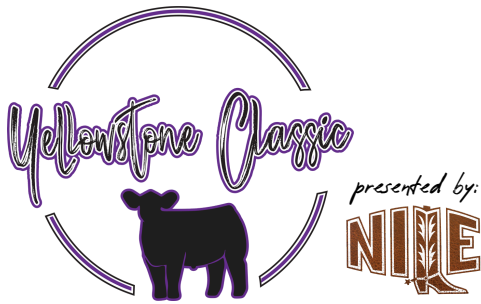
